

WAIVER AND RELEASE OF LIABILITY FOR EXPOSURE TO COVID-19

Jessica Olson Piano Studio and Jessica Olson, individually, may elect to offer in-person piano lessons ("Lessons") during the course of the global Covid-19 pandemic. The undersigned student wishes to attend Lessons. As a condition of being able to attend Lessons, the student or their legal guardian acknowledge the warnings below, agree to comply with the requirements set forth below, and provide a release of liability as set forth below.

1. Adherence to Social Distancing Practices. As a condition of taking Lessons, the student or their legal guardian agree to comply with all safety policies and procedures set out in Jessica Olson Piano Studio's Studio Policy Addendum 2020-2021. The student or their legal guardian further agree to follow teacher instructions regarding masks, social distancing, and sanitation practices during Lessons.
2. Prohibitions on Attendance. The student or their legal guardian acknowledge and agree that no person may enter or attend Lessons if that person has or has had in the past fourteen (14) days fever or symptoms of any illness, has tested positive for Covid-19, has been in close contact with someone who has tested positive for Covid-19, has traveled outside of Gallatin County, Montana, or has hosted guests from outside Gallatin County, Montana.
3. Advisory. Students or their legal guardians are advised that if they are age 65 or over or have any health risks such as asthma, heart problems, chronic lung or kidney disease, diabetes, comprised immune system, liver disease, or severe obesity, they are at a greater risk of serious illness or death if they contract COVID-19. Any individual with any of these ailments or conditions, or any student who resides with an individual with any of these ailments or conditions, is advised not to attend Lessons.
4. Assumption of Risk. Regardless of adherence to health department requirements and recommendations, as well as social distancing practices, there is a risk of COVID-19 exposure whenever an individual enters a building with other people. By attending Lessons, the student or their legal guardian acknowledge and agree that the student and their household is assuming the risk of COVID-19 exposure.
5. Release of Liability. To the greatest extent allowed by law, the student or their legal guardian hereby agree to release and hold harmless Jessica Olson Piano Studio, Jessica Olson, individually, and any person residing at 3465 Beaverhead St., Bozeman, MT 59718, from any and all illnesses, injuries, sickness, death, or other losses arising in any way from Lessons, including, but not limited to, exposure to COVID-19.
